Sub : Empanelment of CGHS approved Private /Health Care Organizations (HCOs) / Hospitals with Indian Council of Forestry Research & Education/RFRI for medical facility to RFRI Jorhat employees .


Sir,

In accordance with the provision contained in para 3(h) of MOA signed between CGHS and HCOs and in terms of recognition granted to ICFRE by the Ministry of Health and Family Welfare conveyed vide MoEF&CC letter No.2-48/2011-FE, dated 01.04.2015, I am directed to convey the approval of the DG,ICFRE for empanelment of following CGHS approved Private/Health Care Organizations (HCOs)/Hospitals at Guwahati, subject to the condition that respective hospitals/diagnostic centers gives consent to provide medical facilities, on the same terms, conditions and prescribed rate/package rates as applicable under CGHS of Govt. of India till the Hospital/Diagnostic Centre is empanelled with MOH&FW for providing health service under CGH Scheme. The hospitals/diagnostic centers, as has been proposed vide your letter No.3/240/2010(A)-Ests/1688, dated 24th March,2015, No.3/240/2010(A)-Estt, dated 11th Sept., 2015 and No.3/289/2016-Estt/1124, dated 16th August,2016 are:

- (i) Down Town Hospital, GS Road, Dispur, Guwahati,
- (ii) Narayana Hrudalaya Pvt. Ltd. Amingaon, Guwahati,
- (iii) SRL Diagnostic, Sky Lab. Assam, Ulubari, GS Road, Guwahati
- (iv) Ultracare Diagnostic Centre, Beltola Survey, HS Road, Guwahati.
- (v) Niramoi Hospital, Jail Road, Jorhat.
- (vi) Aditya Diagnostic & Hospital, Paltan Bazar, Dibrugarh-5.
- (vii) International Hospital, Lotus Tower, G.S. Road, Guwahati

2. The cashless facilities would not be applicable to employees/beneficiaries/dependent members of an employees family. The beneficiary must compulsorily carry his/her Identity Card/dependent proof at the time of registration at the empanelled hospital/diagnostic centre to avoid any inconvenience to them.
